Collecting Large Size Notes by Signature Combination

The Black Eagle

By Sergio Sanchez

I wrote an article for the Greensheet on the topic of collecting by signature combinations (June 1999 - Woodchopper Pioneer Family Series). Today, I am writing about



probably the most popular collected Large Size Note "The Black Eagle."

This Note is very popular because of its beautiful design. It is also the only U.S. Note with the portraits of two presidents, and is still very affordable to own at this time. This Note was engraved by G.F.C. Smillie, and was

first issued in 1899. The design has the American Eagle over the portraits of Presidents Abraham Lincoln and numbers. Friedberg numbers 229a



Ulysses S. Grant. The Black Eagle was issued with a total of 11 different signature combinations and in 3 varieties, date above serial number, date below serial number and date to the right of seal. The Black Eagles go from Friedberg numbers 226 through 236. Friedberg number 226 has the date above the serial numbers.

through 236 have the date to the right of the seal.

The Black Eagle was issued as a Silver Certificate, and a total of 3,744 Billion Notes were printed. (Ref: The Comprehensive Catalog of US Paper Money, By Hessler, Chambliss of 2006) Yes, over *three billion* Notes were printed. That's a lot of Notes.

Granted, all Notes printed might not have been released for circulation by the government, yet even if 80% were released; it still leaves a lot of notes, over 2 billion. It is simple. The life expectancy of Paper Money compared to coins does not even come close.

Here you will find a chart with information pertaining to the various Friedberg numbers, Notes printed of each, total number known, Circulated amounts known and Uncirculated amounts known. If you notice the rarity factor of three of these Notes Friedberg 231, the Napier/ Thompson signature combination

with 212 Notes, is the rarest of them all. There

are two other Black Eagles,

Friedberg 227 and Friedberg 229a, with 655 and 266 Notes known in all grades. I would like for you to notice how many possible sets including all 13 varieties could be assembled. That's right. 212 sets so far from what is reported. This includes Circulated, and Uncirculated Notes Known. As far as an uncirculated set, only 23 can be assembled.

So, if you would like to venture off in a great challenge to assemble one of these sets, try it. You will have lots of fun and if you are successful, you will be one of the privileged to own one. I owned a complete Gem set of the 13 varieties, and I had a great time putting it together.

All I can say if you want to put a set together, go for it now while they are still affordable and possible, because the more collectors who join our

Gold Discovery in the Platte River in 1858 and the Denver Mint

From Placer Mining to Gruber & Co

It was tough to become wealthy in the 1899's if your background was lower or middle class. Daily necessities

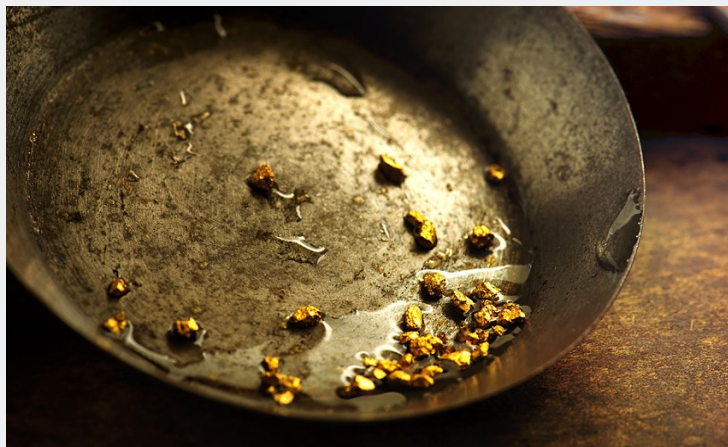


required a regular job and sometimes made advanced education impractical. Avenues to better lives were limited. Today lottery tickets are often the desperate hope of those who are living in conditions they wish to improve. In the 1800's the discovery of gold fired the imaginations of many men aspiring to make their fortunes. The scramble to assemble minimal equipment, acquire transportation and travel to the gold 'fields' came to be known as a "Gold Rush."

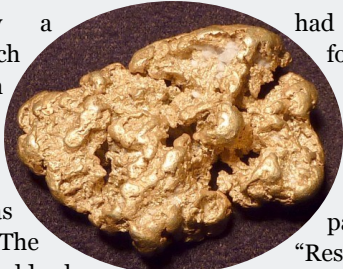
One such discovery took place on the Platte River near what is now Denver city in 1858. At the time the area was frontier wilderness and it was two years later (February 28, 1861) that Congress created the Territory of Colorado. Travel hardships and enmity

from the area's Indian tribes increased the risk and difficulty of the journey to the Platte.

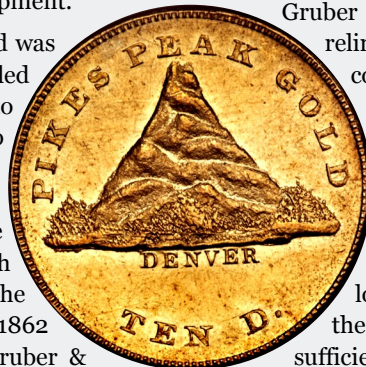
The technique used at first was placer mining. Gold



migrated due to water pressure or due to earth movement; and accumulated due to its weight into some kind of backwash area—called a “pocket.” One method of acquiring this gold was to use the gold pan. Another method uses a construction called a “slew” or “launder” (essentially a trough through which river water is routed in order to wash gravel and soil past riffles or matting in order to catch the heavier gold as it settles to the bottom. The gravel and soil would be shoveled into the trough. Another more complicated method was “dredging” which required much more construction and equipment.



The resulting gold was often in a form called ‘gold dust’ and had to be converted into some practical way to use it as money. This was tough because there wasn’t much circulating money in the area. In 1860 to 1862 three firms--Clark, Gruber & Co., John Parsons & Co. and John Conway & Co.—who minted \$5 and \$10 gold pieces.



Congress approved an Act in April 21, 1862 authorizing the establishment of a mint in Denver. \$75,000 was allotted to establish this mint and fund the expenses for it in the fiscal year 1863. It was to mint gold coins exclusively. In June of 1862 a committee was appointed to research and organize the fulfillment of this Act.

It appeared that the purchase of Clark, Gruber & Co. was the most

efficient way to proceed. In November of 1862 an offer of \$25,000 was proffered to the company for the purchase of the building, equipment, supplies and the land. This sale was delayed by a problem of a ‘clouded’ title to the land since no land office had ever been established for that district.

The simple fix was for Congress to pass a resolution on March 3, 1863 which stated in part:

“Resolved by the Senate and House of Representatives of the U.S.A. ... That the Secretary of the Treasury ... is hereby, authorized to receive and accept from said Clarke, Gruber and Company such relinquishments; and conveyances of their right and claim to said lots and property as ... the Secretary shall deem sufficient for the extinguishment of any claim, right to said lots and property as ... the Secretary shall deem sufficient for the extinguishment of any claim, right or title which the said Clarke, Gruber and Company may or can have thereto. And said lots and property shall thereafter be reserved from public sale, preemption, or homestead settlement, and shall remain the property of the United States.”

What an extraordinary real estate transaction! The U.S. took title in April 1863; and, after transporting equipment and reconstructing the building, the Denver Mint opened in September 1863.

In the early stages of this mint, it did not mint coins, but melted, refined assayed and stamped bullion which was then returned to the depositors in unparted bars, stamped with the weight and fineness. Staff included a superintendent, assayer, coiner, melter and refiner—although the mint still did not mint coinage.

The placer gold in the Platte River area appeared exhausted by 1867; and the miners turned to lode mining with high percentages of gold and silver. In 1869 Congress provided that the Denver establishment would be designated as and assay office with an assayer in charge. It was decided that the amount of bullion



deposited did not merit its designation of Branch Mint with a full corps of officers. Congress passed an act February 20, 1895, providing again for the establishment of a mint at Denver Colorado for the coinage of gold and silver.

The original site at the old Clarke, Gruber & Co. was considered inadequate; and the old mint assayer's office was sold by an Act of Congress on June 30, 1906. The funds were applied to the costs of finishing the new mint on property located at West Colfax and Delaware Street.

The new building was occupied in 1904 but the coinage operations did not begin until February 1906.

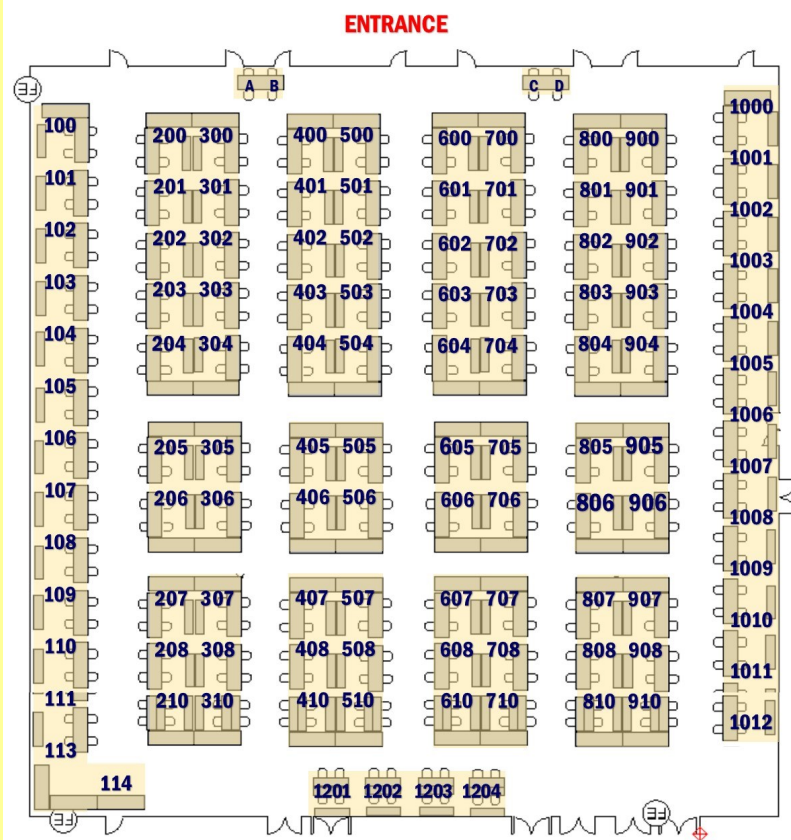
