# **BOURSE AGREEMENT TERMS & CONDITIONS**

Operated and owned by CK Shows, A Nevada Corporation

## **IMPORTANT! PLEASE READ**

**Bourse Inclusions.** Bourse fee includes a table(s), electric hookup, four chairs and one back up table. Safe is available at an additional charge. Exhibitor application is subject to acceptance by CK SHOWS. Table assistants MUST be employees or agents of the Exhibitor requesting badge. THIS POLICY IS STRICTLY ENFORCED. Exhibitors may share tables at NO CHARGE. All BADGE HOLDERS and TABLE SHARES must be submitted to CK SHOWS 45 days prior to the Show. Four (4) Exhibitor Badges per application. Lost or additional Badges are \$25. LIMIT four (4) Validations per show. It is unlikely that Exhibitor will be able to add tables to an existing location. **Security and Liability.** Armed Security will be present 12 noon Thursday to 6pm Sunday. Armed Security will be locked in the hall Thursday, Friday and Saturday evening. Armed Security Personnel will roam the hall during show hours. By signing this agreement the Exhibitor understands and acknowledges that any Security Personnel at the show will try to maintain order and prevent criminal acts that are visible to him/her. There can be no assurance that the Security Personnel can stop crime. Exhibitor and their agents agree to be solely responsible for any theft, damage or disappearance of their merchandise and will insure said merchandise. Exhibitor and their agents guarantee to hold harmless CK SHOWS, Las Vegas Numismatic Society (hereafter referred to as LVNS), the Westgate Resort & Casino (hereafter referred to as the Resort) and their officers, agents and representatives from any claim whatsoever resulting from their participation in this Show, including, but not limited to, theft/loss of merchandise, injury to their person, agents, assistants, spectators and/or employees, as well as disgruntled customers or fraudulent actions by others. These terms are extended to include the security room, which opens at 5pm on Wednesday.

**Cancellations.** The Exhibitor understands that there are no conditions under which that CK SHOWS, LVNS and their officers, agents and or employees shall be liable for any payments or monies to Exhibitor or their agents for any reason related attending this Show, including, but not limited to, travel to and from the Show and/or damage to any of Exhibitor's property. If the Show shall be cancelled for any reason, there are no circumstances under which CK SHOWS or LVNS will be liable for any more than the total bourse fees paid to CK SHOWS. No refunds will be given unless written cancellation is received in our office at least 45 days prior to the first day of the Show.

**Conditions.** The Exhibitor agrees to adhere to all terms and conditions governing the Show whether created by CK SHOWS, the Resort or Clark County, NV. The Resort has strict rules regarding the distribution of flyers and advertisements in the casino. The Exhibitor may distribute flyers or printed material within the Show confines. The Exhibitor agrees to conduct business according to the laws of the state of Nevada. The Exhibitor understands that CK SHOWS is a Nevada Corporation and that this agreement is deemed to have been signed and approved or rejected within the state of Nevada. Booth location is at the sole discretion of CK SHOWS and its officers or agents. Bourse locations are not transferrable without the express written consent of CK SHOWS.

**Resort Guidelines - Tabletop Displays.** Table Top Displays are defined as promotional/ educational/ sales materials or items etc. that are restricted to the top of one (1) table and may extend no higher than 36" above table top surface. Display materials may not exceed 250lbs per display area & must be located either on top of or under (hidden from view) the display table. The Convention Services Manager will ensure that all resort policies are fully adhered to and retains the ultimate authority to restrict access to any party that is not in full compliance. Incoming and outgoing shipments are routed through the Resort Business Center. All shipments are subject to current receiving and storage charges. Shipments will not be accepted more than three (3) days prior to set up date. Resort assumes absolutely no responsibility for material handling. Individuals are responsible for transporting material to and from the Business Center without the aid of resort equipment or resort labor. Individual vendors are responsible for storage of all material brought in to the resort and for complete removal of said material upon departure. Set up/tear down of Table Top Display areas must conform to contracted program times.

**Resort Guidelines - Exhibits.** Resort does not have storage space for crates. However, the Resort will accept a limited amount of convention material and freight through our Business Center at prevailing rates. Exhibitors and Organization shall indemnify and hold harmless Resort and its servicing agents from all liability (damage or accident) which might ensue from any cause resulting or connected with transportation, placing, removal or display of exhibits.

**Resort Guidelines - Food and Beverages.** No food or beverages may be brought into the convention center that was not purchased at the Resort or from from of its approved vendors. This policy is STRICTLY ENFORCED.

**Other Liabilities.** Exhibitor shall be fully responsible to pay any and all damages to property owned by the Resort, its owners or managers, which result from any act or omission of exhibitor. Exhibitor agrees to defend, indemnify and hold harmless, the Resort, CK Shows, LVNS and any of their respective owners, managers, officers or directors, agents, employees, subsidiaries and affiliates, from any damage or charges resulting from exhibitor's use of the property. Exhibitor's liability shall include all losses, costs, damages or expenses arising from, out of, or by reason of any accident or bodily injury or other occurrences to any person or persons, including the exhibitor, its agents, employees and business invitees which arise from or out of the exhibitor's occupancy and use of the exhibition premises, the Resort or any part thereof.
